

ATTENTION: Follow tracking of your transfer to the store. Please wait 24 hours until your transfer is ready for pickup. We receive hundreds of guns each week that have to be booked into our system in the order in which they are received. If it has not been 24 hours and you come into the store to pickup your transfer, you will have to wait to pick up your transfer until it is booked into our system.

Terms & Conditions

- The person listed on the packing slip or transfer invoice is the only one able to pick up the firearm. Minors are prohibited from doing FFL Transfers.
- **NOTE:** 18-21 year old will be delayed by the NICS system automatically for a minim of 10 days. This is a new federal law (Dec. 2022), this is not optional.
- We are a retail gun shop. We charge a fee for transferers with prior approval (\$25) and charge an additional fee (\$75) for items without prior approval. We are not affiliated with any other gun shops or warehouses.
- Users of Gunbroker are required to contact us prior to bidding to request a transfer.
- Any item arriving at WTP Arms that is broken, misidentified, or in any condition different that the buyer expects is the responsibility of the SELLER to rectify and NOT WTP Arms. It is the responsibility of the buyer to contact the seller and make arrangements. Transfer fees will still be assessed for both intake and outgoing items regardless.
- It is the customer's responsibility to make sure the shipper sends us an FFL and a bill of sale with purchaser's name and phone number listed. No transfer will be picked up before we receive these items. We are required by law to obtain these items the same day as we receive the firearm.
- If we do not receive the bill of sale and FFL with the firearm shipment, we charge a \$10 RESEARCH FEE. This fee will be paid prior to pickup. All boxes containing items sent to us for transfer will be opened and inspected.
- Purchasing a Gun for someone else, even online is illegal and considered a "Straw Purchase." If you are not the actual transferee/buyer, we will not transfer the firearm(s) under U.S.C. 922(g), (n) or (x). If we can not legally transfer the item there will be a \$100 FEE that covers our processing fee's in and out.

Customer will have 1 Week to have arrangements to ship firearm(s) out of WTP Arms.

We reserve the right to retain item(s) as WTP inventory if Customer has no arrangements after 30 days. No recourse will be due to the customer. Abandoned or forfeit items will be sold to recoup fees, etc.

- -If a customer sends a firearm to us for transfer and the customer is DENIED on their NICS background check, the customer is responsible for the \$100 DENIAL FEE that covers our processing fee's in and out. Customer is also responsible for SHIPPING to return the firearm to the seller. Additionally, the customer is responsible to arrange shipping by providing the shipping label and any required information. We will NOT ship the firearm back to the seller until these items are paid in full.
- We reserve the right to cancel or refuse ANY FFL Transfer at our discretion .
- Transfers are not a requirement of the FFL. They are done as a service to customers.
